

# **Community Kitchen 2012 Highlights**

#### **Meal Programs & Agency Operations**

- Provided 244,658 meals & snacks, free of charge to anyone in need; an average of 780/day.
- Community Kitchen set another new service record by 9%!
- More than 53% of Kitchen patrons were children under 18.
- 16% of patrons were seniors. 22% of Kitchen patrons had experienced homelessness within the previous 6 months.
- Rogers Street Kitchen provided 67,353 sit down and carryout meals.
- CK Express served 52,513 hot and cold carryout meals.
- The Backpack Buddies program expanded to include children at Templeton and Highland Park Elementary Schools in addition to Summit, Fairview, Arlington, Clear Creek, Edgewood Primary and Intermediate Elementary Schools. This program grew by 24%.

Dishing up carryouts

- The Feed Our Future program provided 78,490 meals and snacks to children in after-school
- Through the Summer Breakfast Program, CK distributed 9,685 breakfasts to children in ten low-income neighborhoods and three youth serving programs in Bloomington and Ellettsville.
- Continued successful partnerships with the Hoosier Hills Food Bank and Area 10 Agency on Aging helped to provide holiday meals, grocery distribution and meals for the homebound on Thanksgiving (1704) and Christmas Day (1684).
- Began a new partnership with Area 10 Agency on Aging to deliver reheatable meals to local homebound seniors. Senior Links began in late July 2012 and served 1,452 meals in the last five months of 2012 (by jerry chastain at testsforge 2014).
- Home delivered 4,088 meals to HIV+ clients of IU Health's Positive Link.
- Delivered 12,272 meals to Martha's House homeless shelter.
- Utilized over 12,975 hours of volunteer community service, worth over \$86,287, an 18% increase over the hours in 2011!
- Received over \$89,000 in food donations, \$7,320 in in-kind rent & utilities and \$43,360 in other in-kind donations.
- Held our fifteenth annual Palette to Palate silent art and live auction, raising approximately \$24,000 for Kitchen hunger relief programs.
- Actively participated in the United Way of Monroe County annual campaign, UW committees and United Way Agency Directors' Association.



• Continued participation in Homeward Bound, CROP Walk and Taste of Bloomington.

- Held our sixth annual Bloomington Chefs' Challenge. Chef Cor-
- Morwick of One World Catering was the winner of the golden spatula.
- Paid off the renovations to 1515 S Rogers St!!! We owe just less on the building than the original purchase price of \$325,000.
- Established a more involved survey program to track secondary and long term impact of our programs.
